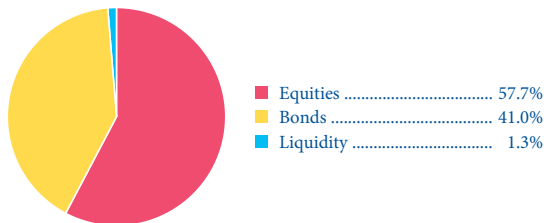

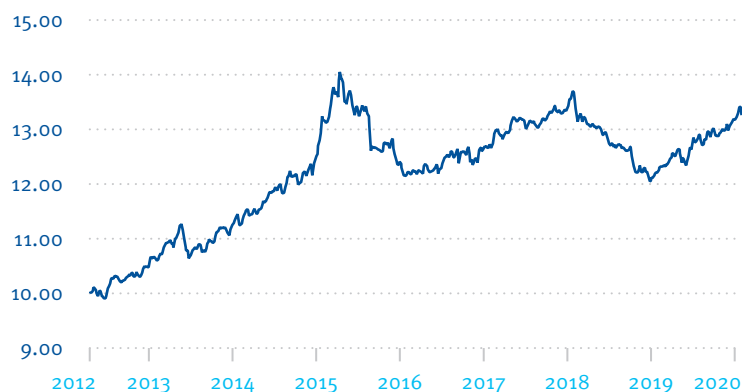
### Risks

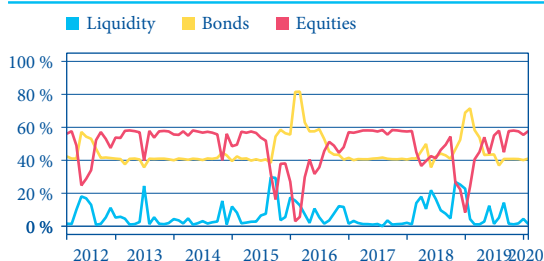
